- **Any relevant background information about areas affected.**

- The Kenya Country Office is located in Nairobi, the capital city of Kenya where the government has set up testing centers and quarantine process has been streamlined with about 21 laboratory testing centers and at least one isolation centre in each of the 47 counties to date in Kenya. The other hotspots are Mombasa, the second largest city in the country, Kilifi and Kwale county which are tourist destinations and Kitui, Kajiado, Kiambu, Machakos, Turkana, Murang'a, Nyeri and Isiolo counties where ChildFund Kenya has presence and implementing programs in partnership with LPs. Mandera county in the North Eastern region bordering Ethiopia and Somali has emerged as hotspot in the last one week. Kajiado county has seen a surge in cases due to cross-border activities between Kenya and Tanzania. In the last 4 weeks COVID 19 cases have spread from three counties to 21 out of 47 Counties in the country. Of the 21 counties, ChildFund Kenya and its local partners has operations in 12 Counties. Only 14 counties where ChildFund is operating have not recorded any COVID 19 case.

- **Host government posture: Have they declared a state of emergency and/or requested outside assistance? Which nationwide measures has the government taken, e.g., limitation on meetings, internal travel, school closures etc.**

The government has provided a number of directives the first being on 22nd March 2020 when the first ten days after case was reported in the country. The key announcements to date are:

1. On 22nd March 2020 all international flights are suspended effective Wednesday March 25th, 2020 at midnight except for cargo flights whose crew must observe strict guidelines. Kenyans who are currently in foreign countries and will not have come back within the period are advised to observe the guidelines issued in the respective countries wherever they are. Other Countries were given a window period to evacuate their nationals before Wednesday 25th March 2020.
2. Kenyans and foreigners with valid residence permits are allowed to come in to the country on condition that they self-quarantine voluntarily and if note they will be forcefully quarantined for a full period of 14 days at their cost, and thereafter arrested and charged under the Public Health Act.
3. To secure the social distance requirement, effective 22nd March 2020, all bars were closed until further notice and restaurants are to remain open but only for purposes of facilitating take away

services and also all public service vehicles were requested to enforce the directive of social distance. Following the directive of the President on 25th April 2020, partial reopening (05.00 am to 04.00 pm) of hotels, eateries and restaurants with strict adherence to the government's measures against the spread of the deadly virus was announced on 27th April 2020 by National Emergency Response Committee on Coronavirus.

4. There are also directives on social distance hence the suspension of all church, mosques, and other religious gatherings. This also include weddings, funerals and other social gatherings which are restricted to immediate family members only. On 1st June 2020, the president directed the Ministry of Interior & Ministry of Health to continue & hasten their engagement with religious leaders; with the objective of developing protocols that will be adopted to guide a more participatory way of worship while guaranteeing the safety of worshipers.

5. On Wednesday, March 25, announced the government imposed a daily 7pm to 5am curfew effective 27th March in a bid to stem the spread of the novel coronavirus. Subsequently the government has advised employers to consider reducing working hours to enable workers to reach their homes in good time before the curfew hours. On 25th April 2020, nationwide 7pm to 5am curfew was extended by the government by 21 days. On 16th May 2020, nationwide dusk-to-dawn curfew was extended for a further period of 21 days up to and until the 6th June 2020.

6. On Monday 6th April, the President announced further measures to contain spread of COVID-19. He imposed a cessation of all road, rail and air transport from and into Nairobi Metropolitan and the counties of Kilifi, Mombasa and Kwale for a period of 21 days. The order was effective 7pm on 6th April for Nairobi and from 7pm on Wednesday 8th April for Kilifi, Mombasa and Kwale. On 21st April, the cessation imposed on road, rail and air transport was extended to include Mandera County which has experienced a sharp increase in the number of COVID 19 cases. On 25th April 2020, the cessation of movement order affecting Nairobi, Mombasa, Kilifi, Kwale and Mandera counties was extended by 21 days. On 16th May 202 the cessation of movement into and out of the Nairobi Metropolitan Area and the Counties of Kilifi, Kwale, Mombasa and Mandera was extended up to and until the 6th June 2020.

7. Government has also ordered (a) closure of all golf clubs and club houses, (b) closure of open sporting clubs and walking fields and (c) nationwide testing of all health workers and medical staff, including those in private hospitals, rapid response teams and hospital staff.

8. On 16th May 2020, the government announced cessation of movement of persons and any passenger ferrying automobiles and vehicles into and out of the territory of Republic of Kenya through the Kenya-Tanzania, and Kenya-Somalia international border international borders except for cargo vehicles, with effect from midnight today, Saturday 16th, May 2020.

- **What responses has the government put into place to address the health crisis and/or the economic impact?**

In addition to the directives given by the National government on measures to combat and respond to COVID-19, the central Bank of Kenya has also announced measures aimed at alleviating the adverse economic effects of Covid-19. The emergency measures put by the Central Bank of Kenya mainly focus on:

1. Banks to seek to provide relief to borrowers on their personal loans based on their individual circumstances arising from the pandemic.
2. Relief on personal loans, banks will review requests from borrowers for extension of their loan for a period of up to one year.

3. Medium-sized enterprises (SMEs) and corporate borrowers were advised to contact their banks for assessment and restructuring of their loans based on their respective circumstances arising from the pandemic.
4. Banks are to meet all the costs related to the extension and restructuring of loans.
5. To facilitate increased use of mobile digital platforms, banks are to waive all charges for balance inquiry.
6. All charges for transfers between mobile money wallets and bank accounts are eliminated.
7. The government is carrying out an identification and registration of vulnerable families affected by the COVID 19 with plans to provide them with a cash transfer support. A total of 8.5 billion has been set aside to provide food support to vulnerable families. Distribution is earmarked to start this week. The government has begun the process of identifying the vulnerable families for the cash transfer support in addition to fast-tracking the ongoing monthly cash-transfer support to vulnerable elderly population (above 70 years). Cash transfer to the elderly and vulnerable families have begun.
- Other measure the government have undertaken include:
 8. Several county governments such as Kwale, Machakos and Nakuru have suspended payment of market fees for small traders and other county levies.
 9. The government is in the process of hiring 1,000 more health workers to boost its capacity. The government is finalizing hiring of further 5,000 healthcare workers to be posted in various counties.
 10. The government is scaling up the acquisition of personal protective equipment (PPE) for health workers
 11. The government has begun mopping up surplus food supplies in the country as part of its preparedness in combating the coronavirus pandemic.
 12. The government has issued fiscal measures to cushion salaried staff and business from the negative impact of COVID-19
 13. The government of Denmark has boosted Kenya's fight against the coronavirus disease (COVID-19) with a Sh320 million (22 million Danish Kroner) donation to the country's emergency fund. This is in addition to the additional Sh5.2 billion (\$50 million) credit from the World Bank.
 14. The announcement of the rollout of the National Hygiene Programme on April 29th, 2020 as an initiative that will help create a healthier environment and jobs, with the first phase employing 26,148 workers over 30 days and more than 100,000 youths progressively.
 15. The Gov't released Sh8.7bn for needy families under the social protection program. The Cash transfer has started.
 16. The government has directed the testing of all truck drivers immediately at all border crossing points and the county governments to increase the training of their health care workers. Testing of all truck drivers begun and has led to identification of positive cases among truck drivers. On 16th May 2020, the government announced that all drivers of the cargo vehicles shall be subjected to mandatory COVID-19 disease testing and will only be granted entry into the territory of the Republic of Kenya if they test negative. To address the truck drivers' challenges of having tested in time at border point, the government introduced mobile testing labs at major border points.
 17. The government has urged Kenyans to maintain a healthy diet as the country fights to contain the spread of Covid-19. To facilitate this, the government has launched a campaign where one

million households will be facilitated to set up kitchen vegetable gardens. The project will be beneficial for both rural and urban dwellers in all the 47 counties.

18. From 25th April, all employed Kenyans started benefiting from fiscal measures (income tax relief of 5%) undertaken by the government to cushion people from the negative implications. On 23th May 2020, the government outlined the 8 point economic stimulus package aimed at reviving the economy.

19. The government has announced that those people who violate the curfew rule will no longer be held at quarantine centres. The Inspector General of police will identify and designate places where curfew rule offenders will be held.

20. The government has started Mass testing in hotspot estates in Nairobi (Kawangware & Eastleigh) and Mombasa (Old Town). On 6th May 2020, the government announced cessation of movements in and out of Eastleigh in Nairobi and Old Town in Mombasa. On 9th May, the government introduced stricter new measures in the 2 areas which included prohibition of hawking, prohibition of any gatherings of any nature, continued closure of malls, eateries and restaurants. On 20th May 2020, the government extended cessation of movement in and out of Eastleigh in Nairobi as well as prohibition of hawking, prohibition of any gatherings of any nature, continued closure of malls, eateries and restaurants until Saturday, the 6th June 2020.

21. The government have started flying back Kenya citizens stranded abroad. Citizens from UK, India and China have been flown back.

22. The government has reported that it has so far trained 11,000 health workers across the country to tackle the COVID-19 pandemic. Another 60,000 community health workers have been trained to enhance the Ministry of Health human resource capacity in health facilities across the country.

23. The government has started *Kazi Mtaani* (job in informal settlements) programme spearheaded by the State Department of Housing and Urban Development geared at integrating 26,000 jobless youth in urban hygiene and sanitation works across 23 informal settlements.

- **What travel restrictions has the government put in place for travelers entering the country?**

1. Passengers coming into the Kenya from 22nd March 2020 will undergo mandatory quarantine at a government designated facility at their own expense. All international flights to and from Kenya have also been suspended.
2. All road, rail and air transport to and from Nairobi Metropolitan and three counties of Mombasa, Kwale and Kilifi prohibited for a period of 21 days from Monday 6th for Nairobi and Wednesday 8th April for Mombasa, Kwale and Kilifi. Transport into and out of Madera has also been closed for 21 days effective 22 April 2020. Kilifi County government also imposed more stringent measures where they withdraw passes of all essential staff and vehicles that were allowed to cross to Mombasa and other neighboring counties. On 25th April 2020, the cessation of all forms of transport to and from Nairobi Metropolitan and four counties of Mombasa, Kwale, Kilifi and Mandera was extended by the government for the next 21 days.
3. All passengers in public vehicles must wear a facemask.

- **What issues are children in these areas facing (food shortages, safety concerns, schools' closure, etc.)?** All school and other learning institution in Kenya were closed between on 16th to 20th March, but the period has been since extended indefinitely following a presidential directive as part of government effort to combat the Corona Virus. On 26th April, the government extended school closure for one-month effective May 4th, 2020 which was the initial opening date. On 1st

June 2020, the president directed the Ministry of Education to fast-track & finalize the ongoing consultations with the stakeholders that will provide an appropriate calendar for gradual resumption of education in the country. Some families particularly those living in urban informal settlements are starting to face food shortage because they don't have money to buy food. Shortages of water supply has also started being experienced especially in urban informal settlements. Most of the population living in the informal settlements depend on daily wages to buy food and other basic need for their families. Since most companies have suspended activities, casual laborers are unable to find work to earn daily wages.

- **Child protection risks caused or exacerbated by crisis situation.** Currently we don't have factual information on the situation. However, given that children and community members are all at home following the closure of schools and suspension of some economic activities, it is likely that some children will be exposed to child protection issues. We are working with our LPs to monitor the situation.

 - (c) COVID Response Subgroups on Informal Settlements; People Living with Disability, ASALs/Pastoralists, Youth and Children, M&E Surveillance and Research and Gender
 - (d) Kenya Humanitarian Partnership Team (KHPT) composed of UN, INGOs and donors such as USAID

3.b. Program Response

- **What kind of response activities or interventions have been executed? What support items are needed or have been collected/distributed?**

ChildFund Kenya and its local partners has undertaken the following interventions:

1. Provided cash transfers to **3361** vulnerable sponsored households by ChildFund Kenya and LPs while other 40 Households were linked to government Cash Transfer by the local partners.

2. Distributed Soap, Sanitizers, and handwashing stations to households and in communities. Over 2800 sponsored family households were supported with sanitizers and/or soap in Nairobi and Narok, Nyeri and Laikipia counties. In Nairobi 40 community handwashing vessel/stations were provided. Also 3000 water storage jerrycan are in the process of being delivered to households in Kasarani and Mukuru informal settlements in Nairobi county. E vouchers for Hand sanitizers and water storage tanks are being finalized for beneficiaries in Mukuru and Kasarani.
3. Awareness and sensitization outreaches have been done in most of the counties where ChildFund Kenya operates. These included outreach caravans, distribution of pamphlets and radio announcements and talk shows.
4. In four counties ChildFund Local partners have participated and supported the county government in the coordination of COVID19 response. Marsabit, Nawiri facilitated coordination meeting where 20 people of the COVID 19 coordination team participated. In Narok and Kitui and Machakos, the local LPs supported the county government to organize the meetings.
5. Distribution of 40 hand washing stations in Mukuru informal settlement. Additionally, 30 hand washing stations were distributed in Kisumu informal settlements (Manyatta, Obunga and Nyalenda).
6. Cash transfer of USD 35 (KES 3500) conducted for 315 households in Lake Region.
7. In Central Rift, 487 HH were supported through cash transfer of 30USD to enable them purchase food rations and sanitation items.
8. In Samburu, WASH commodities (liquid soaps, sanitizers, handwashing vessels, Face Masks) were provided to 70 HHs at USD 10 per HH.
9. Supported 207 and 111 HHs in Lake region and Central Rift respectively with a cash transfer of 30 USD (Central Rift) and 35 USD (Lake Region).

Overall, the response will pick up in the coming weeks as LPs finalized their plans and agreed with respective government on priorities. Some of the items which are needed are:

- (a) More funds for Cash Transfer – it is estimated that over 26,000 Households will required food and non-food item support;
- (b) PPE to support county medical personal and community volunteers. This is emerging as a main challenge as the number of COVID19 cases increase
- (c) Soap and Sanitizer – these are consumables and they will have to be replenished at least every 2 weeks. The 2800 household supported will need replenishment and other 23,000 households will require new provisions.
- (d) Sensitization outreaches – more support to County government and community volunteers with pamphlets and materials, including radio, TV and other forms of media.

- **What is the current progress of implementation vs. the established response plan?**

Implementation of the response plan has experienced somewhat slow start, but it is slowly picking up. In the coming weeks most of what has been planned and funds has been raised will be implemented. 9 out of the 13 LPs are already implementing response activities. Implementation of response activities has started in some operation areas, while in others finance approvals for funds are being expedited to avail funds for the activities. Funds for four LPs have been approved and implementing of response activities will start by next week. The plan to support 3,000 vulnerable families in with WASH commodities Mukuru and Kasarani are being finalized by the vendor.

3.b.1. Stop COVID-19 from infecting children and families

ChildFund’s Global Response Plan

To help children and families protect themselves from COVID-19, we are installing community, handwashing stands; educating communities about symptoms, hygiene measures and where to get tested or treatment; and distributing soap, hand sanitizer, gloves and masks to families and frontline, health workers. For children who are being treated for COVID-19 or are subject to quarantine measures, we are creating child-friendly spaces with age-appropriate toys and reading matter.

To reduce infecting children and families, we have scaled down on all activities require bring children and their caregivers together. We have provided sanitizers and/or soap to over 2800 sponsored households in Nairobi and Narok, Nyeri and Laikipia counties. In Nairobi 40 community handwashing vessel/stations were provided. Also 3,000 water storage jerrycan are in the process of being delivered to households in Kasarani and Mukuru informal settlements in Nairobi county. We supported 440 families with children 0-3 yrs with hand washing water dispensers for domestic use.

Community Health Volunteers have been trained and carried out sensitization of Covid-19 both prevention in about 1895 households both in Mukuru and Kasarani. About 1000 brochures have been designed and printing is ongoing. These will be used by CHVs in their sensitization. All the CHVs involved in the 12 sensitizations have been provided with hand sanitizers, protective gears, masks, disposable gloves to be used during the exercise.

Most LPs have intensified awareness and sensitization in the communities in collaboration with county governments. They have also compiled the support they need and will be rolling out more activities after review and approval of their requests. In Kajiado, 750 handwashing vessels and soaps were procured and will be distributed this week. Cash Transfer of USD15 to 70 HHs with an estimated population of 210 children in Samburu to support them purchase hand sanitizers and facemasks.

LPs are working with county governments to supporting field COVID response teams (volunteers, police, Administration and mobile testing centers), staff & volunteers with face masks and hand sanitizers. Some LPs have installed hand washing stands in their offices as one of the COVID 19 prevention measures. One

LP (Childrise) has started production of facemasks in their tailoring unit that was supported by ChildFund Kenya for distribution to enrolled children and parents. Currently, they are producing average of 250 masks per day and target to distribute a total of 6000 masks.

In Makueni and Kajiado, the LP engaged youths who were supported with vocational skills (tailoring and dress making) to make face masks for all the enrolled children. In Embu, the LP made and distributed 3500 facemasks to enrolled children. In Marsabit, the LP supported sensitization meetings targeting market areas and shopping Centres. One COVID 19 Response County Steering Group meeting was also supported. In Samburu, WASH commodities (liquid soaps, sanitizers, handwashing vessels, Face Masks) were provided to 70 HHs. In Nairobi, 40 handwashing stations were distributed for use by vulnerable households within Mukuru informal settlements. In Kisumu, 30 handwashing stations were distributed for use by vulnerable households within Nyalenda, Obunga and Manyatta informal settlements.

In Eastern region, the LP in collaboration with MOH and Afya Halisi Programme distributed 960 facemask to 48 health facilities (20 each facility), 37 hand washing stations, 370 hand sanitizers and 39 COVID - 19 sensitization materials to the dispensaries to help in the fight against COVID-19. The LP also partnered with World Vision, Konza Technopolis, Plan International, Golden Africa, Kenya Commercial Bank, Broadway Bakery, Kifaru Millers, Orbit Chemicals and distributed hand washing stations, cooking oil, maize flour, wheat flour, hand sanitizers, tents, chairs and thermometers.

In Samburu, the LP provided 350 handwashing facilities, 1050 face masks and 350 containers of 500mls liquid soaps to 350 HHs. In Kajiado East Sub-County, the LP (EDCA) provided 44 households with 500ml of liquid soap each.

In Isiolo, the LP supported 50 vulnerable families (43 Females, 7 Males) with hand washing water vessels. The LP continued carrying out sensitization on COVID – 19 through media (Radio spots Advert) with awareness messages for children and their families in different.

3.b.2. Ensure that children get food they need

ChildFund's Global Response Plan

To ensure that the most vulnerable families can keep food on the table, pay rent and cover other basic needs, we are providing cash for those families most needing this support, such as those who have lost their income because of COVID-19, child or elder-headed households, and/or households affected by disability or chronic illness. Where possible, we are distributing food and basic household items directly, carefully abiding by COVID-19 protection measures

200 households in Nairobi are being supported monthly through cash Transfers to purchase food and other household necessities. Each household was given a monthly cash transfer of Kshs. 3,000 (USD 30) using mobile money transfer. The LPs are also linking vulnerable families with national government social welfare programme. The LPs are also providing food items to vulnerable families. So far 66 vulnerable households in Kajiado East Sub-County have been provided with food items directly (maize, beans, porridge flour, cooking oil and salt) at 15 USD per HH by the LP (EDCA).

3.b.2. 1. Cash Transfers and vouchers

So far we have made monthly Cash Transfers totaling to \$91,936.00 to 3361 households. In Nairobi, cash Transfer of \$ 6,000 to 200 households was done. E vouchers were also to assist 500 households in informal settlements in Nairobi (Mukuru and Kasarani) acquire WASH equipment and materials (water storage tanks, soaps, sanitizers, etc.).

3.b.3. Keep children safe from Violence: physically and emotionally

ChildFund’s Global Response Plan
 We are supporting community-based child protection systems that identify, respond to and refer cases of abuse, neglect, violence or exploitation. We are also providing virtual, online psychological first aid and counseling, and supporting temporary shelters for children who live on the street, providing hygiene supplies, food and other basics. We are also arranging safe and appropriate care for children who are separated from their caregivers due to treatment or prevention measures.

- community leadership structures and formal CP response systems have been fully mobilized and working closely in ensuring that any cases of child abuse are reported and addressed. In Nairobi, 4 children who were unwell were referred to Access *Afia* (health) for treatment and discharged. The LPs are also supporting the efforts of the county government and other child led agencies in quarantining street children and their families to safer and secure location. In Isiolo, the street shelter programme was supported with 20 mattresses and 10 Insecticide Treated Nets.
- 1000 children provided with Psychosocial Support
- The LPs are maintaining close contact and on watch with the child protection committees at the community level in order to respond in case any child protection cases are reported. They are working closely with the Community Health Volunteers to ensure close monitoring of children adherence to COVID19 safety guidelines.
- In Kisumu, the LP supported 10 community child protection officers in tracking and reporting cases of abuse, neglect, violence or exploitation in relation to Covid 19 in their respective communities with monthly stipends (transport and lunch allowance) through the department of children services in Nyando, Nyakach and Kisumu Central Sub-counties. In Eastern region, the LP

supported 42 Child Welfare Protection Committee members, 50 Community Health Volunteers and 3 CHEWs to undertake home visits to 70 Households in Masaku Site.

- In Samburu, Community sensitization on child protection through CHVs/Health personnel and local FMs was done with an estimate target of 9,000 in collaboration with of USAID-AMREF and Department of children services.
- In Kisumu, the LP (KDP) supported child protection officers in Kisumu Central, Nyando and Nyakach Sub-Counties in tracking and reporting cases of abuse, neglect, violence or exploitation in their respective communities with monthly stipends.
- In partnership with other stakeholders, the LP supported street children in Isiolo County with food and non - food items (20 Mattresses, assorted foodstuffs and ITNs). A total number of 23 children (19 boys, 4 girls) were rescued from streets within Isiolo town.

3.b.4. Help children continue to do their job: Learning

ChildFund’s Global Response Plan

While schools remain closed, we are supporting children’s learning through activities and tutoring sessions online or by radio. For students without reliable internet access, we are distributing home learning kits with materials and guides for their use.

- Sharing of information with parents and children on how to access learning through the media as provided by the Ministry of Education under Google classes, EDU TV and WhatsApp lessons.

LPs are sharing information with HHs on how/where to access education opportunities using the bulk SMS platforms. Learning guides provided to 2100 children in Nyeri and Laikipia counties. In Makueni and Kajiado, the LP has opened up its resource centre to 5 youths to support them with online e-learning classes.

3.b.5. Other responses

- LPs have supported county government efforts to carry out fumigations in Nairobi, Kitui and Migwani Towns. Including fumigation of the LPs offices.
- LPs are supporting county governments coordination of COVID-19 Response forums by mobilizing community leaders and youths in their operational areas.
- KDP While schools remain closed, we are supporting children’s learning through activities and tutoring sessions online or by radio. For students without reliable internet access, we are distributing home learning kits with materials and guides for their use.
- Sensitization through 10 focus groups in North Horr Sub County in Marsabit County was done targeting 12 villages, 7 community health volunteers and sponsorship parent volunteers to assist children access online and e-learnings through television, radio talks and radio spots.

Part 6 Safety & Security

Are police and other services functioning in the normal manner?

Police services are functioning in the normal manner however, they have intensified government directives enforcement operations across the country in efforts to contain transmission of Coronavirus.

The enforcement of the Public Order Number 1 on the Coronavirus pandemic has the following key aspects:

1. That effective Friday 27th March 2020, there will be a daily curfew from 7pm to 5am in the morning and this shall be in effect in the territory of the Republic of Kenya with all movement by persons not authorized to do so or not being medical professionals, health workers, critical and essential service providers being prohibited between these hours.
2. The management of the Kenya Ferry Services Limited is now also under the National Police Service, the Coast Guard and National Government Administration Officers (Ngao).
3. National Emergency Response Committee (NERC) has decided that all persons who violate the self-quarantine requirement will be forcefully quarantined for a full period of 14 days at their cost, and thereafter arrested and charged under the Public Health Act
4. To enforce the directive of social distance requirement in the public transport sector of all public service vehicles

5. To ensure all bars S will remain closed until further notice. Restaurants are to remain open but only for purposes of facilitating take away services. This is meant to secure the social distance requirement, noting the increased risk of transmission these facilities cause.
6. The enforcement of the NERC has directive of the suspension of all church, mosques, and other religious gatherings. This also include weddings, funerals and other social gatherings which are restricted to immediate family members only.
7. Regular police initially manning the four set barriers to prevent people movements in and out of Nairobi metropolitan were replaced with paramilitary General Service Unit (GSU) officers to ensure strict enforcement of the directive. This was after reports that some people were sneaking into Nairobi metropolis through “Panya” (unofficial/illegal) routes.
8. The Chief Administrative Secretary (CAS) for Health Dr. Mercy Mwangangi, stated on April 19 that individuals found violating the curfew and other regulations imposed by the government will be assumed to have been in contact with suspected COVID 19 patients and will be required to undergo a 14 day quarantine period.
9. On April 15, the Inspector General of Police Hilary Mutyambai said putting on a mask to prevent the spread of the coronavirus in the country is now compulsory in line with the gazette notice issued by the Office of the Attorney General on April 6, 2020. According to the gazette notice, failure to wear a face mask is punishable by a fine of Ksh.20,000 or six-month jail term or both.
10. The nationwide extension by President Uhuru Kenyatta of dusk to dawn (1900 – 0500hrs) curfew as well as the ban on movement in and out of the Nairobi Metropolitan area and the counties of Kilifi, Kwale, Mandera and Mombasa by an additional 21 days effective 25th April.
11. The nationwide announcement by the Cabinet Secretary for Education George Magoha on extension of closure of learning institutions by a month up to 4^h June. However national exams remain as scheduled.
12. On May 3, the National Emergency Response Committee (NERC) directed the Inspector General of Police Hillary Mutyambai to designate a containment camps for those flaunting curfew guidelines. The committee asserted that the new facilities must be able to meet the social distancing requirement as per the MoH’s guidelines.
13. On May 4, the Kenyan government through the Ministry of Health indicated that the country has been approved by the World Health Organization (WHO) to conduct clinical trials of Remdesivir, a drug that may be effective in treating COVID-19. The Ministry of Health (MOH) stated that it would begin using the drug in select patients who have tested positive for the disease and are showing more severe symptoms. Remdesivir was earlier approved by the US Food and Drug Authority as an emergency treatment for COVID-19 however, data on its overall effectiveness remains limited.
14. Seventeen cadres of health professionals demanding better workplace protections in the wake of the coronavirus outbreak in the country this week issued a 14-day strike notice to the government.
15. On May 6, the Cabinet Secretary for Health, Mutahi Kagwe announced the imposition of an order for the cessation of all movements into and out of the Eastleigh and Old Town areas in the Counties of Nairobi and Mombasa respectively effective from 1900hrs on 6th May for 15 days.
16. On May 11, the Director of Public Health Dr Francis Kuria announced designated stopover areas for truckers and scaled up testing capacity for cargo transporters at border points in a bid to contain the spread of the COVID-19 pandemic. The stopovers are Malaba, Gilgil, Mlolongo and Mariakani for Mombasa – Malaba route, and Molologo for Namanga - Nairobi route.

17. On May 11, government said that all patients who will be admitted to hospitals have to undergo Covid-19 test as a prerequisite for admission. Health Services Director General Dr Patrick Amoth said testing of patients for the respiratory disease is meant to reduce the risk posed to healthcare workers and to protect other patients whose immunity may be compromised. To date 34 healthcare workers have been diagnosed with Covid-19.
18. On May 12, the Ministry of Health (MoH) in partnership with county governments has begun enhancing capacity in prisons to combat the spread of the coronavirus. The ministry has identified prisons as one of the high-risk areas after some inmates in Industrial Area Prison tested positive.
19. On May 22, Kenya and Tanzania resolved their border dispute and agreed to re-open the borders which had earlier been closed following an escalation over cross - border coronavirus disease (COVID 19) cases.
20. On May 23, President Uhuru Kenyatta outlined KES 53.7 bn (USD 502) stimulus package plan targeting small and medium enterprises, the tourism and health sectors and agricultures companies among others, in a bid to ease the negative economic effects of the COVID 19 pandemic.
21. On May 24, the Ministry of Health Chief Administrative Secretary (CAS) Rashid Aman, reported that exercises of contact tracing of individuals who had come into close contact with those diagnosed with COVID 19 have been obstructed by individuals providing fraudulent information on their respective contact details forms.
22. On May 25, the Nairobi Metropolitan Service (NMS) which is conducting free mass testing exercises in areas of concern to hasten the isolation of confirmed cases reported to have tested at least 3000 persons since the exercise was launched on 20th May 2020. The exercise is aimed at mapping out the hotspot areas for the COVID -19 disease. Further, officials responsible for the exercise stated that it is focused on informal settlements due to the inherent challenges experienced in these areas related to social distancing.
23. On June 2, international and local media reports indicated that at least 15 civilians have been killed by police officers implementing the government - imposed restrictions. The Independent Policing Oversight Authority (IPOA) Chairperson Anne Makori, announced that 15 deaths and 31 incidents where victims sustained injuries were directly linked to actions of police officers during the curfew enforcement operations. IPOA stated that it had received 87 complaints against police officers which include deaths, shootings, alleged harassment, assaults resulting to serious injuries, robbery, and sexual assault which were under investigation.

Are the courts still operating?

The Judiciary temporarily suspended court hearings across the country. This followed the announcement made public by Chief Justice David Maraga in a press statement outside the Supreme Court on Sunday, March 15.

"We have today agreed as follows; in compliance with the directive issued by the National Emergency Response Committee on Corona virus, we shall forthwith scale down court activities throughout the country starting Monday, March 16, for two weeks in order to allow for further consultations and design appropriate measures to prevent the spread of the coronavirus," Maraga stated".

Actions taken by Judiciary:

1. In compliance with the directive issued by the National Emergency and Response Committee, we shall forthwith scale down court activities throughout the country over the next two weeks effective tomorrow, March 16, 2020 in order to allow further consultations and design appropriate measures to prevent the spread of the virus.
2. During this time, prisoners and remandees will not be presented to court.
3. With regards to new arrests, all cases except serious ones will be dealt with at the police stations in accordance with guidelines to be issued by the Inspector General of Police.
4. All appeals, hearings and mentions in Criminal and Civil cases in all courts are suspended with immediate effect.
5. All execution proceedings are also suspended during the two weeks.
6. Courts will continue to handle certificates of urgency and taking plea for serious cases.
7. During this time, all judicial officers and staff will continue being on duty. However, there will be no open court appearances.
8. Judges in all stations will in the meantime review the deserving cases already identified by Prisons authorities and issue appropriate revision orders in an effort to decongest the prisons. Magistrate Courts will also review bail terms for those in remand.
9. All conferences, workshops, colloquia and training programmes are suspended until further notice.
10. There will be no foreign travel for the next 30 days for staff of the justice sector institutions, whether official or private, save for exceptional circumstances.
11. An ad-hoc Inter-Agency Committee has been established to liaise with the National committee and advise the NCAJ on further precautionary measures on an ongoing basis.
12. NCAJ will review these directions from time to time as need arises.
13. Rulings are now been done virtually

14. The Judiciary has maintained temporary suspension of court hearings across the country following the announcement made by the Chief Justice David Maraga in a press statement on March 15.

Are there reports of looting or increased criminality?

The reporting period was marked by continued enforcement of COVID -19 related directives by security forces across the country leading to a number of arrests. Incidents of excessive use of force by police officers continued to embody the threat environment in the capital.

Highlighted below are significant incidents recorded over the reporting period:

- On June 1, an individual was shot and killed by a police officer in Bondeni area, Mathare in Nairobi County who was enforcing the nationwide dusk - to - dawn curfew that was imposed to control the spread of COVID -19.
- On May 31, patrons were arrested at the Guava Pub in Hurlingham, Nairobi County for violating COVID -19 related directive.
- On May 31, four Chinese nationals were arrested in Kigumo, Murang'a County for allegedly conducting unauthorized COVID -19 screening tests on their employees.
- On May 31, officials from the Directorate of Criminal Investigations (DCI) arrested two suspects in Kisii County linked to the fraudulent distribution of COVID -19 relief stipends. The individuals had reportedly impersonated government officials and were defrauding residents of KES 599 (USD 6) claiming that they would be enlisted for future government stipends as a result of their payment.
- On May 31, thirty-one (31) prisoners were evacuated from the Nairobi Remand & Allocation Prison in Nairobi county after testing positive for COVID -19.
- On May 29, forty individuals were arrested for flouting COVID -19 related directive while jogging in Kisumu, Kisumu County.
- On May 27, an individual was arrested for violating COVID -19 curfew directive in Kahawa West, Kiambu County.
- On May 26, reports indicated that police officers in Homa Bay, Homa Bay County arrested three Tanzanian nationals who had illegally entered the country from Tanzania against the government directive requiring the closure of borders amid the coronavirus disease (COVID 19) pandemic.
- On May 25, an individual was assaulted by civilians in Chebilat - Bomet County, who were enforcing the government requirement for the mandatory use of facemasks while in public spaces.
- On May 25, reports indicated that over 20 individuals were hospitalized after consuming contaminated relief food which was had been distributed by unknown persons. The contaminated food was labelled the 'William Ruto Foundation' and 'Kimani Ichugwa which parties denied association with the contaminated donation.
- On May 23, an individual was shot and injured by police officers in Doldol - Laikipia County, during an attempted arrest linked to the alleged breach of coronavirus disease (COVID 19) related directives.
- On May 22, twelve individuals escaped from the COVID -19 isolation facility at St Mary's Mabera Secondary School in Migori County.

- On May 22, reports indicate that police officers discharged tear gas in Mlango Kubwa in Eastleigh, Nairobi county in efforts to disperse crowds who were attempting to forcefully gain entry into the Eastleigh area where a localized cessation of movement order had been imposed in efforts to curb the spread of the coronavirus disease (COVID 19).
- On May 21, cross border cargo transporters staged protests at the Malaba Border in Busia County, following allegations that the Ugandan government was discriminating against Kenyan nationals over the ongoing coronavirus disease (COVID 19) pandemic and causing significant delays at the crossing.
- Between May the 21 and 26, at least 140 individuals were arrested by police officers in Narok, Samburu and Nairobi counties for flouting government directives related to prevention and protection against the spread of COVID -19 e.g. wearing facemasks in public places and social distancing.
- On May 12, the management and employees of Mac's Pharmaceuticals in South B, Nairobi county were arrested by police officers for operating during curfew hours and for violating a directive issued by the Pharmacy and Poisons Board (PPB) prohibiting the production of drugs for a 12 month period.
- On May 11, Eastleigh residents staged protest in Nairobi county, demanding food distribution from the government following the localized cessation of movement order aimed at curbing the spread of the coronavirus disease (COVID-19).
- Between May 5 - 10, police officers arrested at least 89 individuals including Kariobangi Member of County Assembly (MCA) in Nairobi, Kiambu, Murang'a, Mombasa, Migori, Turkana, and Kitui counties who had breached the cessation of movement and social distancing order which had been put in place to curb the spread of the coronavirus disease (COVID 19).
- On May 11, resident engaged police in armed confrontation during enforcement of COVID 19 directive, Coral Bells Apartments, Thindigua, Kiambu County.
- On May 7, police officers discharged tear gas and used live ammunition to disperse crowds that had gathered in the vicinity of St Bakhita Catholic School at Imara Daima in Nairobi county in violation of coronavirus disease (COVID 19) related to social gathering directives.
- On May 7, police officers mounted roadblocks cordoning off the Eastleigh area in efforts to enforce the cessation of movement order which was imposed in the area to curb the spread of coronavirus disease (COVID -19). Reports indicated that police officers deployed teargas and water cannons to disperse residents who had congregated in the streets.
- On May 6, four individuals were arrested in Changamwe Mombasa County, on allegations of having impersonated police officers enforcing the government-imposed curfew, which had been put in place to curb the spread of the coronavirus disease (COVID 19).
- On May 4, area residents staged protests along Thika Road, in the vicinity of Utalii Hotel in Nairobi over an alleged earlier killing of a local resident by police who was found violating the government - imposed coronavirus disease (COVID 19) curfew order.
- On May 4, an individual was reportedly assaulted by police officers in Muthingiini, Makueni County, who were enforcing the curfew put in place to curb the spread of the coronavirus disease (COVID-19).
- On May 3, an individual was assaulted and killed by police officers enforcing the government-imposed curfew directives in the vicinity of the Baraka Medical Centre, Mathare in Nairobi county following a verbal confrontation.
- On May 3, the body of a police officer who had been enforcing the government - imposed COVID 19 related curfew was discovered along the Bondora Mwakirunge Road in Rabai, Kilifi County. Reports indicated that the officer was attacked by unidentified assailants.

- On April 30, police arrested 16 church goers for violating COVID 19 related social distancing directives in Kitengela, Kajiado County.
- On April 29, one suspect was arrested after police raided residence and impounded COVID 19 related contraband in Meru County.
- On April 28, coronavirus disease (COVID-19) cases in the country rose to 374 including 14 fatalities. The Ministry of Health indicated that 124 patients had been discharged after recovering from the disease.
- On April 28, Cabinet Secretary for the Ministry of Interior Fred Matiang'i announced an extension to the cessation of movement order limiting travel in and out of the Kakuma and Dadaab refugee camps from 29th April, in efforts to further help contain the spread of the coronavirus disease (COVID 19).
- On April 28, two individuals escaped from an isolation facility identified as the Wambugu Farm Centre in Nyeri County, which had been set up due to concerns over the spread of the coronavirus disease (COVID 19).
- On April 27, the Cabinet Secretary for the Ministry of Health Mutahi Kagwe announced that restaurants will be allowed to reopen to the public however, instituting strict rules on physical distancing measures to prevent the spread of COVID 19. Further, he said that the establishments will only be allowed to operate between 0500hrs and 1600hrs.
- On April 27, massive 35 kilometers traffic jam was reported at Malaba border as COVID -19 mass testing of truck drivers begun. The drivers claimed that the exercise was taking long and urged the government to increase the health workers conducting the testing to expedite the exercise.
- On April 26, three armed assailants accessed Farasi Garden Villas in Kitusuru - Nairobi County, restraining two security guards that were patrolling the premises and robbed one of the residences on the compound an unconfirmed number of valuables. The assailants managed to escape following the incident.
- On April 26, ten bar patrons were arrested by police for violating COVID -19 related government directives in Likoni, Mombasa County.
- On April 26, at least 57 individuals were arrested for flouting COVID 19 related public gatherings restrictions in Saboti, Trans - Nzoia County.
- On April 25, seven individuals were arrested for violating COVID 19 government-imposed curfew in Kisii town, Kisii County.
- On April 25 during a press briefing, President Kenyatta extended the nationwide dusk to dawn (1900 – 0500hrs) curfew as well as the ban on movement in and out of the Nairobi Metropolitan area and the counties of Kilifi, Kwale, Mandera and Mombasa by an additional 21 days.
- On April 24, dozens of worshippers from Kiteje Kwale County, were arrested for breaching several COVID-19 related directives, including social distancing guidelines, a ban on public gatherings and the requirement to wear face masks when in public. The worshippers were preparing for Iftar following the first day of fasting.
- On 23 April, 16 individuals including one police officer were arrested in Nyandarua County on allegations of having violated social distancing government directives aimed at curbing the spread of coronavirus disease (COVID-19).
- On April 23, one individual who had reportedly escaped from a coronavirus disease (COVID-19) isolation Centre at the Kenya Medical Training College was arrested by police officers at his residence in Cheplanget in Kericho County.

- On April 22, twenty-one youth were arrested by police officers following a raised alarm by residents in Nakuru County over allegations of defying the government-imposed coronavirus disease (COVID 19) related curfew.
- On April 22, the Governor of Garissa County, Ali Korane, ordered the partial closure of the County's borders with Isiolo and Wajir Counties in efforts to help curb the spread of the coronavirus disease (COVID-19). No public service vehicles (PSVs) will be allowed into the County, while only cargo lorries and persons travelling on foot who have undergone health screenings will be allowed in.
- On April 22, the Human Rights Watch (a Civil Society group), issued a report which claimed that police officers in Kenya were using excessive force when implementing the dusk to dawn curfew that had been imposed by the government. According to the report, at least six individuals had died because of excessive force between 27th March and 5th April 2020.
- On April 21, police officers arrested 30 individuals in Emali Makueni County, on allegations of having contravened a social distancing directive issued by the government and aimed at curbing the spread of the COVID 19.
- On April 21, thirty-three congregants and a pastor were arrested at the Ngurubani Market in Mwea East, Kirinyaga County, on allegations of having flouted coronavirus disease (COVID 19) related social distancing directives.
- On April 20, fifty individuals who had been placed under isolation over coronavirus disease (COVID 19) concerns escaped from the Kenya Medical Training College in Upper hill, Nairobi County.
- On April 20, two police officers were arrested in Matuga Kwale County, on allegations of having facilitated illegal inter-county movement during the government-imposed travel restrictions meant to curb the spread of the coronavirus disease (COVID 19).
- On April 20, an individual was arrested on allegations of having illegally procured uniforms belonging to the National Police Service, which he used to impersonate police officers while enforcing the government-imposed dusk to dawn curfew in Mombasa, Mombasa County.
- On April 20, thirty-nine individuals were arrested at Nasra Estate in Komarok, Nairobi county on allegations of having contravened a social distancing directive aimed at curbing the spread of the coronavirus disease.
- On April 20, more than 450 people were placed on mandatory two weeks quarantine across the country for defying a national curfew order imposed by President Uhuru Kenyatta, in measures aimed at preventing the spread of coronavirus.
- At least 55 individuals were arrested on April 19 at different churches across Trans Nzoia County, in violation of a government regulation banning religious gatherings in an effort to contain the spread of the coronavirus disease.
- On April 19, police officers arrested a priest and 12 other individuals who were attending a church service at Mbololo in Taita - Taveta County, contrary to a government directive banning religious gatherings.
- On April 19, at least seven individuals reportedly travelled from Nairobi in violation of a cessation of movement order aimed at preventing further spread of COVID-19 were arrested by police officers manning a roadblock in Kutus, Kirinyaga County.
- Still on April 19, unknown assailants broke into several vehicles in Parkland area of Nairobi and stole valuables such as stereos and other electronics. The incidents were reportedly conducted during the dusk to dawn hours of the government-imposed curfew.
- On April 18, at least 20 individuals were arrested at the Konar House Hotel restaurant along Menelik Road, Kilimani Nairobi, in violation of COVID 19 social distancing regulation.

- On April 17, twenty-four individuals are reported to have illegally entered Bomet County from coronavirus disease prone counties in contravention of the government directive which restricted travel out of counties which were adversely affected by the disease. However, security agents were reportedly searching for the individuals.
- On April 16, twenty-three individuals were arrested by police officers in Kyuso, Kitui County for failing to adhere to social distancing directives which were aimed at curbing the spread of the coronavirus disease.
- On 11 April, an unidentified member of parliament (MP) was arrested alongside other individuals at an entertainment establishment in Ruai, Nairobi County for flouting curfew regulations.
- On April 10, two individuals were killed during a stampede at the District Commissioner's office in Kibera, Nairobi County when a crowd of residents forced their way into the compound to receive foodstuffs that had been donated amidst the ongoing COVID – 19 outbreak.
- On April 9, an individual was detained by police after escaping from mandatory COVID-19 quarantine in Chebukwabi, Bungoma County.
- On April 9, a priest was arrested following his release from Kenyatta National Hospital on allegations of having failed to adhere to coronavirus disease (COVID 19 self-quarantine directive).
- Still on April 9, the County Governments of Mandera and Marsabit moved to suspend all inter - county movement effective from April 9 for an initial 21 – day period in abide to contain the spread of COVID-19. Similar restrictions were also been imposed in Isiolo County.
- On April 7, Government Security Response, Kakamega – Police officers discharged tear gas to disperse traders at a market in Mumias town, Kakamega County, while enforcing a government directive aimed at curbing the spread of the coronavirus disease (COVID-19). One individual was reportedly killed during the incident.
- On April 6, Government Security Response, Nairobi – Reports indicated that 21 members of the Sonko Rescue Team (SRT) were arrested in Nairobi on allegations of having contravened the government-imposed dusk-to dawn curfew.
- On April 6 – Nine bar patrons including seven police officers were arrested for violating COVID-19 directive, Makongeni, Thika.
- On April 5 – Police arrest 14 individuals including several police officers for patronizing a bar in violation of a COVID-19 related government directive, Kangundo Road, Nairobi
- On April 5 – Fourteen bar patrons arrested for violating COVID-19 related government directive, Muranga County
- On April 3 – Deputy Governor of Kilifi arrested by police for leaving mandatory quarantine, Coast General Hospital, Mombasa County
- On March 31, over 700 individuals detained from hotel for flouting COVID 19 related directive, Manager arrested, Machakos County Reports indicated that police officers detained a group of some 700 individuals who had congregated at the Maanzoni Lodge in Machakos County against the government directive limiting large social gatherings The Manager of the establishment was reportedly arrested.
- On March 30, Police fire live ammunition, tear gas, in effort to disperse crowd in violation of COVID 19 directive, Majengo Shauri Moyo Reports indicated that multiple gunshots and teargas were fired in the air by police officers in Majengo Area, Shauri Moyo Nairobi County Unverified reports stated that police were dispersing patrons at a local bar.
- On March 30, Individual killed by stray bullet while police attempt to enforce COVID 19 related directive, Kiamaiko An individual was shot and killed by a stray bullet which was allegedly fired

- by a police officer in an attempt to disperse a crowd in violation of a government directive aimed at curbing the spread of the coronavirus disease (COVID 19
- On March 30, Police intercept motor vehicle transporting narcotics, Marsabit County Police intercepted a motor vehicle transporting 56 bales of cannabis in Lokole Merti Marsabit County. The assailants allegedly engaged police officers in an armed clash, injuring one police officer. One suspect was subsequently arrested.
 - On March 29, Journalist assaulted by police officers, Mitunguu Market, Imenti South, Meru County.
 - On March 28, Police discharge tear gas to disperse crowd, Kondele, Kisumu County
 - On March 28, Church clergy and 46 congregants arrested by police in enforcement operation, Bungoma County.
 - On March 28, Police discharge tear gas to disperse traders in violation of government directive, Narok, Narok County
 - On March 26, riots reported as commuters clash with police over curfew enforcement, Likoni Ferry, Mombasa, Mombasa County.

Yes, taskforce was formed that developed and updated a COVID-19 Contingency plan for ChildFund Kenya, that has now been approved.

Based on the contingency plan, Kenya Country office is in phase 2 (Partially working from home). This means that as an office we shall adopt a rotational working basis; some colleagues working from home while others working from the office on a rotational basis. The remote partial working arrangements commenced on Monday 30th March and will be reviewed and updated regularly.
