**Part 1: The Overall Situation**

As of 10 Nov 2020, the Government of Indonesia has announced 444,348 confirmed cases of COVID-19 across all provinces, with deaths 14,761 and 375,741 people have recovered from the illness and over 4.8 million specimens have been tested by using the Real Time Polymerase Chain Reaction Assay and the Molecular Rapid Test for Tuberculosis methods since the beginning of the outbreak. To increase the country's COVID-19 testing capacity, the Ministry of Defense and the Indonesian Army are currently acquiring 17 mobile Polymerase Chain Reaction (PCR) laboratories for 17 army hospitals across the country. As of 10 Nov, most confirmed cases were in Jakarta, East Java, West Java, Central Java and South Sulawesi.

With a 2020 state budget (APBN – the National Revenue and Expenditure Budget) of IDR 2,739.1 trillion, the Government of Indonesia has spent around IDR 1,841 trillion as per September (reaching 67.2 percent), apart from the Regional Revenue and Expenditure Budget (APBD). Majority of APBN and APBDs are allocated for activities that would trigger economic recovery. Moreover, on 4 November, the Committee for the COVID-19 Response and National Economic Recovery (PC-PEN) explained the use of funds for handling the COVID-19 pandemic. The overall level of spending reached 52.8 percent, which is IDR.366.86 trillion from the allocated IDR.695.2 trillion. The utilization of funds per main sectors are as follows:

- Social protection programs: 86.51 percent (IDR.176.38 trillion from the allocated IDR.203.9 trillion);
- Medium, small and micro enterprises (MSME) sector: 75.81 percent (IDR.93.59 trillion from the allocated IDR.123.47 trillion);
- Ministries / agencies and local governments programs: (IDR 30.25 trillion from the target of IDR.106.11 trillion);
- Incentives for new businesses: 29.43 percent (IDR 35.49 trillion from the IDR.120.61 trillion budget); and
- The fund of IDR 53.6 trillion for the corporate financing sector remained unspent.

In addition, the Presidential Productive Assistance has disbursed IDR.22.1 trillion out of IDR.28.8 trillion (76.77 percent), that benefitted 9.2 million business from the target of 12 million MSMEs.

Meanwhile, the implementation of the People's Business Credit (KUR)<sup>1</sup> between January and October 2020 reached IDR.148.38 trillion (78.09 percent of the 2020 target of IDR.190 trillion) and has been used by 4.5 million debtors. The Coordinating Minister for Economic Affairs explained that the KUR implementation has been greatly affected by the COVID-19 pandemic situation; with disbursements for a total of IDR.18.99 trillion in March 2020, to only IDR.4.76 trillion in May 2020, which then increased to IDR 17.72 trillion in October 2020. The KUR disbursements during 2020 were made as follows: a proportion of super-micro KUR (for individuals affected by termination of employment or housewives with productive

businesses) of 3.02 percent, micro KUR of 65.74 percent, small KUR of 31.02 percent, and a KUR dedicated to Indonesian workers abroad of 0.23 percent. The government plans to add IDR.5.33 trillion to the Credit total fund and to increase the allocation of IDR. 292 billion through the Ministry of Cooperatives and MSMEs.

The Indonesian Government plans to continue social assistance through the Family Hope Program (PKH) and the sembako / Non-Cash Food Assistance (BPNT) programs throughout 2021, with target beneficiaries of 10 million families and 20 million families respectively. Meanwhile, the Jabodetabek Cash Assistance and Cash Assistance for non-PKH, which have a target of 9 million families respectively, are planned to continue at least until June 2021, as explained by the Minister of Social Affairs on 5 November, after a ministerial meeting that discussed the possible evaluation of social assistance in the first-to-third quarters, progress in the fourth quarter and the plan for social assistance in 2021. Social assistance in 2021 will still be managed by the Ministry of Social Affairs and the Ministry of Villages, Development of Disadvantaged Areas, and Transmigration.

In another occasion, the Minister of Health shared an update indicating that the Government will maximize the use of social assistance programs such as the Family Hope Program (PKH) and Non-Cash Food Assistance (BPNT) to support stunting prevention in Indonesia. The Minister explained that the current rate of stunting in children under five years of age is at 27.6%, with the National Medium-Term Development Plan for 2020-2024 (RPJMN) at a target of below 20 percent. The COVID-19 pandemic situation has brought an adverse effect on achieving the goal, by limiting access to healthy food, disrupting family income and overwhelming health facilities.

The Pre-Employment Card Program is currently entering its 11th batch, which will accept around 382,000 individuals. In previous batches (1 to 10), a total of 36,044,167 people registered, and 5,597,179 selected people have benefited from the program. The Government allocated around IDR 20 trillion to reach the target of 5.6 million individuals. The program is implemented through seven digital platforms with 147 training institutions offering more than 1,534 trainings, and in collaboration with academics to maintain the training quality.

The Jakarta Provincial Government has extended the Large-Scale Social Restrictions (PSBB) transition to the new normal for another two weeks, until 22 November. The Governor highlighted the continuing trend of decreased average occupancy of isolation beds in the last two weeks, from 59 percent on 24 October to 56 percent on 7 November. Similarly, the average occupancy rate of ICU beds has declined from 62 percent on 24 October to 60 percent on 7 November. This data is compiled by the Provincial Government of Jakarta from 98 COVID-19 referral hospitals throughout the capital city. However, epidemiologists have warned that the daily number of COVID-19 tests in Jakarta fluctuates significantly.

Below are the main highlights of the National Clusters:

#### Health:

- On 27 October, the MoH Centre for Health Training (BBPK) and the Indonesian Epidemiologists Association (PAEI) convened a webinar on 'Strengthening frontline surveillance workforce'. WHO highlighted the importance of strengthening International Health Regulations (IHR) core capacities including surveillance and its workforce for containment at source, using the polio outbreak in Indonesia as an example.
- To commemorate World Polio Day on 24 October, WHO and UNICEF published a joint statement calling on the government and health providers to support routine polio vaccination services in Indonesia. It is important to continue polio vaccination during the pandemic to protect children's

health and maintain the hard-earned polio-free status of the country. Access to routine vaccinations and essential health services have been disrupted during the pandemic. Misinformation and community transmission of COVID-19 have raised parental concerns about the safety of visiting health clinics and immunization services and have led to a decrease in attendance. The importance of the vaccination against polio is heightened during this crucial period and the agencies urged the country to stay vigilant in the fight against polio and bolster vaccination services.

- As part of World Polio Day commemoration, Rotary International convened two webinars on 30 and 31 October on polio eradication, current status and challenges. WHO participated and shared experiences and updates on #EndPolio and relevant projects.

**Logistics:**

Following the cold-chain logistics capacity mapping of the Indonesian Cold Chain Association (ARPI), the National Logistics Cluster continues to discuss anticipation of the storage of the COVID-19 vaccine with the Ministry of Health, BNPB, ARPI, WHO, and various private entities.

**WASH:**

The WASH Sub-cluster within the National Displacement and Protection Cluster is finalizing its disaster preparedness plan which describes the resource capacity of its members and partners, and the coordination mechanisms when dealing with large-scale and small-scale disasters. The development of the plan is timely considering the increasing threat of floods, flash floods or landslides triggered by the La-Nina phenomenon. Some other sub-clusters with the Displacement and Protection cluster will follow the development of similar plans or update their mapping capacity.

- What issues are children in these areas facing: during this reporting period, most school are doing home learning. The government do measuring if the school can open for study which it depend on the situation and anticipating by developing guideline if student need to continue home learning.

Part 3: ChildFund’s Response

**3.a. Overall**

Responding to the current situation in Jakarta where ChildFund Country Office located, the country office is open applying staff shifting come to office by using 10-4 approach. The maximum staff come to office should not exceed 25% as regulated by government. All things can do from home should do from home. Country Office allow domestic travel under certain condition by developing domestic travel guidelines which all travel request should approve by Country Director. Spesific domestic travel which the task can replace by consultant are not allow to do. There is no travel for program ceremony, monitoring which can do by phone call/ virtual, training which can organize by virtual, no face to face meeting if the meeting can do by virtual.

**3.b. Program Response**

In order to address the exchange experiences of youth program within the partners, ChildFund Indonesia conduct series webinar (5 times) with differents topic: Inspirative story of youth and class inspiration. Series webinar from 24 Sept to 22 Oct 2020.

Several virtual training begin this month for partners staff where face to face training are not possible to conduct during the pandemic. Emergency Response training sessions begin on November to December, while M&E training continue organize for partners staff.

While writing this sitrep, the education team do scoping mission to Lampung in collaboration with The Habibie Center to conduct scoping visit to gain data and information for the program planning on peace building. The scoping mission expected to strengthen the program development that will implement at Lampung Province.



### 3.b.1. Stop COVID-19 from infecting children and families

#### ChildFund's Global Response Plan

To help children and families protect themselves from COVID-19, we are installing community, handwashing stands; educating communities about symptoms, hygiene measures and where to get tested or treatment; and distributing soap, hand sanitizer, gloves and masks to families and frontline, health workers. For children who are being treated for COVID-19 or are subject to quarantine measures, we are creating child-friendly spaces with age-appropriate toys and reading matter.

The partners continue integrating personal hygiene promotion in regard to avoiding covid19 infection during the community activity which voluntary they conduct or initiate by partners such training, socialization and distribution.

### 3.b.2. Ensure that children get food they need

#### ChildFund's Global Response Plan

To ensure that the most vulnerable families can keep food on the table, pay rent and cover other basic needs, we are providing cash for those families most needing this support, such as those who have lost their income because of COVID-19, child or elder-headed households, and/or households affected by disability or chronic illness. Where possible, we are distributing food and basic household items directly, carefully abiding by COVID-19 protection measures

#### 3.b.2. 1. Cash Transfers and vouchers

- The covid 19 project continue supporting by CF Korea and further post distribution assessment conducted to all beneficiaries. 1,500 family reached by the project in 2 partners.
- With the recent (2<sup>nd</sup> batch of cash transfer), ChildFund Indonesia also will conduct post distribution assessment to beneficiaries. 2,394 family reach by the project in 5 partners.

**3.b.3. Keep children safe from Violence: physically and emotionally**

**ChildFund’s Global Response Plan**

We are supporting community-based child protection systems that identify, respond to and refer cases of abuse, neglect, violence or exploitation. We are also providing virtual, online psychological first aid and counseling, and supporting temporary shelters for children who live on the street, providing hygiene supplies, food and other basics. We are also arranging safe and appropriate care for children who are separated from their caregivers due to treatment or prevention measures.

Along with IJF Coalition, ChildFund engage in promoting violence againce children campaign. Child Merried virtual discussion was conducted on 3 November 2020. The virtual discussion was involve youth group and special guess speaker the commissioner of KPAI (Indonesia Commision of Child Protection).

**3.b.4. Help children continue to do their job: Learning**

**ChildFund’s Global Response Plan**

While schools remain closed, we are supporting children’s learning through activities and tutoring sessions online or by radio. For students without reliable internet access, we are distributing home learning kits with materials and guides for their use.

**3.b.5. Other responses**

ChildFund provided guidelines for parents on how to manage the situation during covid19 hence the children will do a happy home learning session.
